The share grant comprises the share-based portion of the Company's previously disclosed annual compensation to its trustees for fiscal year 2018. Each independent trustee receives at least 50% of their annual fee in the form of shares of the Company, but may elect to receive up to 100% of their annual fee in shares. Per-share value is the average of the closing prices for the Company's common shares on the New York Stock Exchange for the last ten trading days of 2018.
